Cost Structure and Applicable Feed-In Tariffs for Alternative Energy Generation Technologies for Uganda

The Electricity Regulatory Authority (ERA) is a statutory body established under the Electricity Act, 1999, Cap 145, to regulate the generation, transmission, distribution, export/import and sale of electricity in Uganda.

1. The Electricity Regulatory Authority has allocated funds from its budget and intends to use part of the proceeds to acquire consultancy services.
2. The Electricity Regulatory Authority now invites sealed bids from interested eligible bidders for the provision of consultancy services on generation of feed-in-tariffs for projects beyond the hydro resources.
3. Bidding will be conducted in accordance with the Open Domestic Bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and are open to all bidders from eligible source countries.
4. Interested eligible bidders may obtain further information from **The Head Procurement and Disposal Unit**, Electricity Regulatory Authority and inspect the bidding documents at the address given below at 7(a) from **9:00 am to 5:00 pm Monday to Friday except public holidays**.
5. A complete set of Bidding Documents in **English** may be purchased by interested bidders on the submission of a written application to the address below at 7(b) and upon payment of a non-refundable fee of **Ushs.30,000/=(Thirty Thousand Uganda Shillings)**. The method of payment will be to the **ERA Cahier who will issue an ERA receipt of payment** and then pick the bid document from the ERA reception beginning **May 27, 2009**
6. Bids must be delivered to the address below at 7(c) at or before **2:30 pm on June 29, 2009**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 7(d) **at 3:00 pm**
